MINUTES

- A. Call to Order Mr. Benson called the meeting to order at 6:30 pm

- 1. November voting Carol Monness reported that November voting will be held at the First Congregational Church on the corner of Route 65 and Ridge Road, and that there would be \$100 charge. The Brookfield Elementary school will be in session and can't be used.

Mr. Neas will give a copy of the current Dog Ordinance to the owners of dogs causing problems, and invite them to come to the next Board meeting to discuss this situation.
- 5. Josh Jonestein from Green Trails Inn came in to find to out if there was an ordinance addressing loud truck noise. Mr. Benson asked Ms. Rochat to contact VLTC to see if any kind of ordinance was available. The Board will let Mr. Jonestein know those results.

- D. Payroll and AP Warrants Ms. Koren made a motion to accept the September 5, 2024 AP Warrants as presented for a total of \$66,743.43 with the largest amount going to AJ Galfetti for \$18,410.07. Mr. Edson seconded the motion which carried unanimously 5-0-0
- E. Highway Report AJ Galfetti is currently working on Eagle Peak road and the Town's road crew is working on Howe Road which should be done in two weeks. There have been a few problems with the Town trucks, and work on the shed is also. The road crew will also be working on grading the roads.
